Regional Tourism Marketing Plan Adopted By KTCOG Board

Beginning in December 2024, Tourism Directors, Economic Development Directors, Cooperative Extension Directors, and Kerr-Tar Staff came together to develop a Regional Tourism Marketing Plan, with UPLIFTs expertise and guidance. After a year of collaboration, asset mapping, visioning, conducting surveys, and creating itineraries, the Kerr-Tar Regional Tourism Marketing Plan is complete. The plan was adopted by the Kerr-Tar Regional COG Board on January 29, 2026. The next steps are presenting to the Tourism Development Authority Boards in all five counties for adoption. Once all counties have adopted the plan, implementation will begin on July 1, 2026!

ON-THE-JOB TRAINING SUCCESS

R. Collins successfully completed a Work Experience (WEX) assignment with Turning Point from July 30, 2025 to October 3, 2025. During her assignment, she demonstrated strong work ethic, reliability, and a willingness to learn. Due to her positive performance, Turning Point offered her an On-the-job (OJT) training opportunity, which she began on October 6, 2025. After completing her OJT on December 19, 2025 and receiving a satisfactory evaluation, the company hired her on directly as a Program Support Specialist earning \$17.50/hr. This transition reflects the customer's dedication and the effectiveness of the WEX and OJT programs in providing hands-on experience that leads to permanent employment.


The customer has expressed that she is enjoying the work she is doing and is pleased to have secured stable employment with opportunities for continued growth.



DISLOCATED WORKER PROGRAM SUCCESS

Ty'leaha previously held a CDL Class B and had been laid off from her former employer. Following the layoff, she connected with the career advisor at the NC Works Career Center to receive support in re-entering the workforce. Through working closely with the career center staff, she received guidance on interview preparation, including tips on how to confidently present her skills and experience to employers. As a result of this collaboration, the customer successfully secured new

employment on January 7, 2026 as a dump truck driver. This opportunity has allowed her to quickly return to work in her field while continuing to advance her career. She is currently enrolled to start CDL-A training at Piedmont Community College on February 28, 2026, and upon completion of the course on May 3, 2026, she will transition into driving 18-wheelers with her employer. This success highlights the impact of targeted employment services and training support in helping individuals overcome job loss and achieve career advancement.



VANCE COUNTY BUSINESS ROUNDTABLE

Local business leaders and workforce partners gathered at FlexDesk 360 on January 15 for the Vance County Business Roundtable sponsored by the Vance Co Chamber, a collaborative discussion focused on workforce development, education alignment, and talent pipeline strategies.



Attendees shared insights on current workforce challenges, emerging industry needs, and opportunities to strengthen partnerships between businesses, local schools, community colleges, and economic development organizations. The discussion also explored best practices, career pathways, and strategies to ensure the county's workforce is prepared for high-demand industries.

RICE WRAP TOUR




Local partners and workforce development partners had the opportunity to tour Rice Wrap on January 14, gaining an inside look at the company's operations, production processes, and commitment to quality.
