

# ARPA Workshop on Using Funds to Directly Fund a Capital Project

Kerr-Tar Regional Council of Governments is a proud member of the North Carolina Regional Councils of Government and together we are partnering with the University of North Carolina School of Government to offer a new course called From A to Z: Using American Rescue Plan Act Fiscal Recovery Funds to Directly Fund a Capital Project. In this online workshop (via Zoom), we will detail all of the legal requirements involved in spending American Rescue Plan Act Coronoavirus State and Local Fiscal Recovery Funds (ARP/CSLFRF) directly for a capital project. Using a specific capital project as an example, we will highlight the substantive and process requirements for expending ARP/CSLFRF funds appropriately and demonstrate how to adopt and implement the various state and federal budgeting and compliance provisions including:

- Required general policies, internal controls, and procedures
- Eligibility and allowable cost reviews
- Grant project ordinance adoption and amendments
- Accounting
- Conflicts of interest
- Procurement
- Property management
- Program income
- Subawards
- Obligations and disbursements
- Project & Expenditure reports
- Compliance audit





This course will focus on expenditures of a local government's ARP/CSLFRF funds, as well as blending those funds with other local revenues. It will also explore what's required when partnering with another local government entity for the project. Although it will not focus directly on expending State ARP/CSLFRF funds (from State budget appropriations or competitive grants), much of what is presented in this course will apply to those projects too

The course will be held live on August 10, 2022 from 8:00 am-5:00 pm via Zoom. On-demand video recordings of the course will be made available shortly after the live workshop. The on-demand version will be divided into segments that can be viewed separately or as a single course. Both the live and on-demand versions are offered FREE of charge. Participants must still register at the link below to participate in the live course or to receive links to the on-demand video recordings.

# **KTAAA Updates**

Keep an eye out for Kerr-Tar Area Agency on Aging advertising on PATS vans (Person Area Transportation System) starting this month! Ads promoting assistance with Medicare prescription programs will be showcased on the vans.

Plans for new programs and services are in the works, supported by the American Rescue Plan Act grant. These programs and services will support all counties and will begin this month. Home delivered meals, family caregiver support, increased support of programs at the region's senior centers, and other services are available to enable older adults to remain safely in their homes as long as possible.

The fall program schedule is being finalized and there will be a new line-up of health promotion classes available through a variety of community partners, including faith-based organizations. A Tai Chi class will be offered at the Henderson YMCA beginning in August, and a new Powerful Tools for Caregivers course is in the works. This course is scheduled for September 6-October 11 from 10:00-11:30 am on Tuesdays and will be held virtually on Zoom. If your church has a ministry for older members or if your club or community group would like to know more about what we do to promote well-being for older adults, we are happy to provide presentations and materials to discuss how we can assist with evidence-based health promotion programs. These are free to host, all that's needed is the facility!

# Help Shape the Future of North Carolina Transportation

To prepare for the future, the Eastern Transportation Coalition needs your help exploring an alternative approach to the traditional fuel tax, called a Mileage-Based User Fee, and determining if it would be a more equitable and sustainable approach. A Mileage-Based User Fee means drivers only pay for the miles they drive instead of the fuel they buy.

To better understand if this could work, the Coalition is conducting a pilot program in North Carolina and wants you to join and share what you think. It is free to participate, and there are strict privacy protection measures to safeguard your data. Here's how to join the pilot in four easy steps:

- 1. **Enroll:** Fill out the enrollment form by clicking the link on the website
- 2. **Insert:** Plug a small device into your vehicle to record mileage
- 3. **Drive:** Then drive as you normally do
- 4. **Return:** After a few months, mail back the device









\*These steps may vary depending on the mileage-reporting option selected.

The Kerr-Tar COG Planning & Economic Development Department staff are working with Sanford Holshouser Economic Development Consulting to create the 2022-2027 Comprehensive Economic Development Strategy. # **Bike Helmet Distribution Event**

The Kerr-Tar COG's Safe Routes to School Program (SRTS) partnered with the Oxford Housing Authority and the City of Oxford to distribute bike helmets and educate children on safe helmet usage. On Wednesday, July 27, the Oxford Housing Authority held a helmet distribution event for Granville County children. Seventy-five helmets were donated from the 2022 NCDOT Bicycle Helmet Initiative. Safe Routes to School Coordinator Kenia Gomez-Jimenez provided children with interactive helmet fittings and safety materials such as reflector lights and water bottles.

To promote helmet usage and support local bicycle activities, the Division of Bicycle and Pedestrian Transportation within the NCDOT accepts applications from organizations willing to distribute the helmets. The selection process encourages applicants to collaborate with community groups to extend bicycle safety awareness outreach. # Granville & Vance County NCWorks Career Centers Relocating



On Monday, August 1, 2022, NCWorks will consolidate its Granville and Vance County NCWorks Career Center offices and open a new, expanded location at 826 Garnett Street in Henderson. The locations at 111 Hilltop Village in Oxford and 857 S. Beckford Drive in Henderson will no longer be operational and all in-person appointments will be moved to the new Garnett Street location. The new Center will be open to the public beginning August 1.

This move will allow residents of Franklin, Granville, Person, Vance, and Warren Counties to access a unified NCWorks Career Center, increasing the availability of onsite services aimed at assisting jobseekers and employers. Career Center services will continue to be available in all 5 counties of the Kerr-Tar region through in-person access points at workforce partner locations or virtually, by appointment or on a limited schedule.

The new NCWorks Career Center will maintain the previous location's hours of operation, which are Monday, Tuesday, Wednesday, and Friday from 8:30 am to 5:00 pm and Thursday from 8:30 am to 12:00 pm. # Golden LEAF Rural Internship Initiative

This year, Golden LEAF launched the Rural Internship Initiative to provide Golden LEAF Scholars attending a college or university in



North Carolina with professional work experience related to their career field in rural North Carolina communities. Students are able to intern in a wide range of settings including businesses, governmental entities, and nonprofits. Golden LEAF funds the internship initiative through a temporary staffing agency, but it is up to each site to manage and supervise the intern.

Golden LEAF Scholars are responsible for identifying a site to complete their internship. To support this process, Golden LEAF is gathering information from entities who are interested in hosting an intern next summer (2023). If you are willing to host an intern, you can find more information **HERE**. Entities must be located in a **qualifying county**.

The list of interested sites will be shared with Scholars beginning in late summer 2022 as a resource to locate internship sites.
