PUBLIC INPUT OPPORTUNITY: DRAFT 2026-2035 STIP OUTREACH PERIOD

The N.C. Department of Transportation is inviting the public to provide feedback on the Draft 2026-2035 State Transportation Improvement Program (STIP). The STIP is developed under the Strategic Transportation Investments law (STI), which established the Strategic Mobility Formula. Over the past 18 months, NCDOT has worked closely with the public, legislature, local planning organizations, and other stakeholders to implement this law and develop the Draft STIP.

As part of this effort, NCDOT will host regional drop-in sessions across the state between February 17 and March 17, 2025. These sessions and the broader outreach effort aim to gather input on:

- The variety and geographic diversity of projects;
- The process used to develop the STIP;
- Ideas for improvement.



Feedback from these sessions will also help shape the development of the 2028-2037 STIP. 2025 CLEAN FUEL ADVANCED TECHNOLOGY (CFAT) PROJECT GRANT FUNDS AVAILABLE NOW

\$5,900,000 to be awarded for transportation-related emission reductions. The North Carolina Clean Energy Technology Center (NCCETC) at North Carolina State University announces the following request for proposals (RFP) through the 2025 Clean Fuel Advanced Technology (CFAT) project.

This year's initiative will offer \$5.9 million, focused on reducing transportation-related emissions and supported with federal Congestion Mitigation Air Quality (CMAQ)



funding from the N.C. Department of Transportation (DOT).

The primary purpose of the CFAT project is to reduce transportation-related emissions in 24 eligible North Carolina counties; the secondary purpose is to expand the availability of eligible refueling and charging infrastructure.

Project proposals will be limited to a maximum award of \$450,000 with a minimum award of \$5,000. Applications will be due Friday, March 14, 2025. Learn more <u>here</u>.

Projects located in the following counties are eligible for CFAT funding: Cabarrus, Catawba, *Chatham, Davidson, Davie, Durham, Edgecombe, Forsyth, **Franklin**, Gaston, **Granville**, Guilford, *Haywood, *Iredell, Johnston, Lincoln, Mecklenburg, Nash, Orange, **Person**, Rowan, *Swain, Union, Wake, (*Represents partial counties).

Projects for electric vehicle charging stations (EVSE) will be accepted within all 100 counties.

EXECUTIVE ORDER 14173: NEW COMPLIANCE REQUIREMENTS FOR LOCAL GOVERNMENTS



On January 21, 2025, President Trump issued Executive Order 14173, requiring contractors and grant recipients under federal contracts to certify they do not operate Diversity, Equity, and Inclusion (DEI) programs that violate federal anti-discrimination laws. This EO mandates contract clauses that could lead to liability under the False Claims Act for violations. Local governments receiving federal funding, especially those involved in DEIrelated programs, will need to review and certify their compliance with these laws. Agencies have started incorporating these clauses into funding opportunities, and local governments should be prepared for these new requirements, including potential adjustments to grant applications or forfeiting funds. Monitoring these developments is crucial, as legal challenges to the EO are ongoing. To learn more click <u>here</u>.

At a RESA appointment, his Career Advisor introduced him to the WIOA program. After attending an orientation, William met with a Training Placement Coordinator (TPC) to explore his options. Always interested in long-haul trucking, William faced financial constraints in pursuing Commercial Driver's License (CDL) training.

Through the NCWorks Career Center, William learned how WIOA could assist with funding and supportive services. He started his CDL training on October 21, 2024, and completed it by December 20, 2024. Armed with his new license, William quickly secured a full-time job with US Express, offering excellent pay and benefits.
