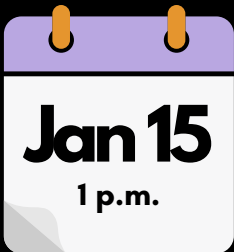

BENCHMARK COMMUNITY BANK OFFERING SCHOLARSHIP



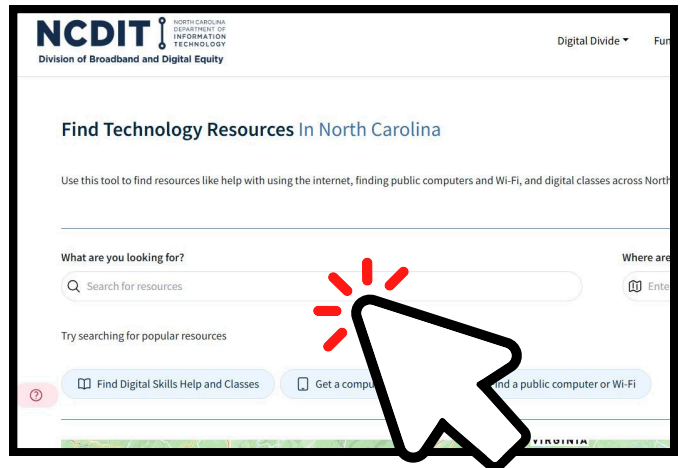

Initially awarding three \$1,000 scholarships in 2015, the program now provides ten scholarships annually. The scholarships aim to recognize students' commitment to school and community involvement and assist those pursuing higher education at community colleges, trade schools, or four-year

During this week, the National Cybersecurity Alliance is promoting an international effort to empower individuals and businesses to respect privacy, safeguard data and enable trust. They want to help citizens understand that they have the power to manage their data, and want to help organizations understand why it is important that they respect their users' data.

LEARN HOW TO PROTECT YOUR DATA:

1. KNOW THE TRADE-OFF BETWEEN PRIVACY AND CONVENIENCE

Consider who you share your data with and what you receive in return.

2. MANAGE YOUR PRIVACY SETTINGS

Check the privacy settings in your apps and devices and adjust them to your comfort level.

3. PROTECT YOUR DATA

Use long, unique passwords, enable multifactor authentication, keep software up to date and watch out for phishing!



FUNDING OPPORTUNITY: COMMUNITY AND DESTINATION CHARGING ZEV INFRASTRUCTURE PROGRAM



The N.C. Division of Air Quality (DAQ) is offering approximately \$1.8 million in funding through the N.C. Volkswagen Settlement to support community and destination zero-emission vehicle charging infrastructure projects. This funding aims to improve charging access across the state, with sites required to include at least one DC Fast port (up to four) and may also have additional Level 2 ports. For more details on eligibility, funding, and project requirements, please refer to the Request for Proposals (RFP). Maximum funding amounts depend on charger capacity and property ownership. On Tuesday, December 17th Workforce Development Director Lou Grillo attended Governor Roy Cooper's A Stronger Workforce for North Carolina event at Durham Tech. The Finish Line Grant was a partnership from July 2018 to October 2022 between the Workforce Development Boards

The program helped many students in the Kerr-Region and was tremendously successful throughout the state as well with over 16,000 awards for a total of more than \$7.5 million.

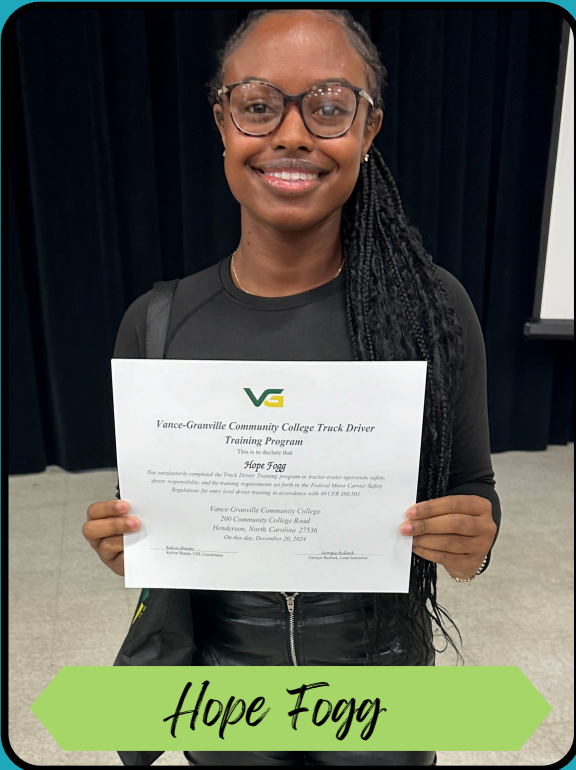

He successfully completed the CDL program on December 20, 2024. Today, Hunter is working full-time with GRD Trucking as a Driver. He is happy to be earning good wages while providing for himself, his fiancé, and newborn son!
